



**INSTRUCTIONS TO VOTERS:** TO VOTE, BLACKEN THE OVAL (●) COMPLETELY, next to the candidate of your choice. To vote for a person not on the ballot, manually WRITE IN his or her name in the space provided then blacken the corresponding Oval (●). To vote in favor of a question darken the oval to the left of the word "YES." To vote against it, darken the oval to the left of the word "NO." Use only pen or pencil. If you spoil your ballot, do not erase, but ask for a new ballot.

**WARNING:** If you receive an absentee or mail-in ballot and return your voted ballot by the deadline, you may not vote at your polling place on election day. If you are unable to return your voted absentee or mail-in ballot by the deadline, you may only vote a provisional ballot at your polling place on election day, unless you surrender your absentee or mail-in ballot and envelope to the judge of elections to be voided to vote by regular ballot.
