1. TO VOTE YOU MUST BLACKEN THE OVAL (●) TO THE LEFT OF YOUR CHOICE COMPLETELY. An oval (●) blackened to the left of the name of any candidate indicates a vote for that candidate.
2. To cast a write-in vote for a person whose name is not on the ballot, you must blacken the oval (●) to the left of the line provided, and write the name in the blank space provided for that purpose.
3. If you make a mistake DO NOT ERASE. Ask for a new ballot.
4. Use blue or black pen for all markings you place on the ballot.
